RACE DAY REGISTRATION: Downtown Beulah (In the Village Park) 6:45 to 7:45 AM.

TIME & PLACE: Monday, July 4th, 2018. 5K starts promptly at 8 am. The Fun Walk/Run starts at 9 am at the park. Both races start and finish near the Village Park in downtown Beulah on Crystal Lake.
